



Permission Slips

For what activities does my child need a Permission slip?

Any St. Anne's Youth Group sponsored event where members are walked to an event or driven in a vehicle by anyone other than their own parents or legal guardians (like in a carpool) requires that a Permission Form be completed and signed by the student's parent or guardian.

What is the purpose of the Permission Form?

There are two different types of Forms, the Annual Permission Form and the Single Event Permission Form; both allow youth group members to participate in a St. Anne's Youth Group event, and in the event of a medical emergency, allow the leaders, volunteers, or adult chaperons of a St. Anne's Youth Group event to administer first aid and/or transport the individual to the nearest doctor or hospital for further medical attention. It also releases St. Anne's Church, its paid staff, and any volunteers helping out, from legal liabilities in the unforeseen event of a health or safety issue involving your son or daughter. Parents are responsible for ensuring that St. Anne's Church has the most current information regarding their son or daughter. A new Annual Permission Form is required if, at any time, there are any changes to the following:

- Current Medications
- Special Medical Instructions
- Emergency Contacts

If you are okay with the risk, please select one of the two Permission Forms available for your use.

1. **Annual Permission Slip:** This document should be filled out once per Youth Group year and used throughout the entire youth group year for all events requiring a Permission Form. It will save you time because you'll only fill it out once for this year. It will be kept on file in the office and will be used if a problem or an accident occurs. Please submit a 2015-2016 Annual Permission Form today if your son or daughter regularly attends St. Anne's Youth Group events. PLEASE NOTE: If any of your information changes, we will need an updated form so that your child is assured of proper treatment, should the need arise.

2. **Single Event Permission slip:** St. Anne's Youth Group will use this document for out of town activities. It is used to let us know that you are giving your child permission to participate in the event and that you are aware that the event takes place outside of Barrhead.

Additional Notes:

Occasionally, an organization or facility will require their own Release of Liability Form. Youth Group members wishing to participate in an event that requires a Permission Form and/or release form must submit a completed one before they can participate.
